

GENERAL SAFETY RULES

PCC Logistics is dedicated to conducting all operations safely and to preventing injury to persons and damage to property. PCC expects all visitors to comply with safety regulations and to conduct all behavior in a safe manner. The following list includes but is not limited to all required safety guidance while at the facility.

Visitors		Visitors must always be accompanied by their host. Visitor badge must be worn at all times at the facility.
COVID-19		Face coverings must be worn at all times at the facility. Social distancing practices should be adhered to the greatest extent possible while at the facility.
Traffic Speed Limit		Visitors must adhere to the traffic speed limits designated throughout the facility.
Acts of Inappropriateness		Any of acts of inappropriateness will result in immediate removal from the facility.
PPE		PPE must be always worn at all times at the facility or in the facility yard.
Drugs & Alcohol		PCC prohibits the use or possession of drugs and alcohol at the facility.
Firearms		PCC prohibits the use or possession of dangerous weapons at the facility.
Under 18		PCC prohibits anyone under 18 years of age from entrance into the warehouse facility or yard. Office visitors must be hosted.
Pets		PCC prohibits pets from entering the premise.
Smoking		Visitors must smoke in designated areas only. The visitor's host should be contacted for any questions.
Food		Visitors must eat in designated areas only. The visitor's host should be contacted for any questions.

Moving Around the Facility		Visitors are encouraged to only walk on marked pedestrian walkways, utilize handrails while on stairs, and remain aware of facility surroundings.
Electronic Use		PCC prohibits the personal use of electronics for video or picture taking other than the client's own products. Headphones and ear bud usage is prohibited.
Hazardous Materials		Hazardous materials may be present at the facility. Visitors should not touch any containers or vessels at the facility. SDS are available at the facility. Eyewash stations are located throughout the facility.
Incidents		In the event of an incident (injury or non-injury), the visitor's host should be notified immediately. An incident report is required to be filled out by the visitor host and visitor.
First Aid		In the event First Aid is required, trained First Aid Responders and First Aid kits are available. The visitor's host should be contacted for any questions.
Emergency Evacuation		In the event the alarm sounds, immediately stop what you are doing and walk to the nearest exit. Do not stop to collect any belongings. All facility personnel should gather at the nearest assembly area and wait for instructions. If in a safe location, call 911. Facility evacuation maps are posted throughout the facility for reference.

REGLAS GENERALES DE SEGURIDAD

PCC Logistics se dedica a realizar todas las operaciones de forma segura y a prevenir lesiones a personas y daños a la propiedad. PCC espera que todos los empleados y visitantes cumplan con las normas de seguridad y conduzcan todo comportamiento de manera segura. La siguiente lista incluye, pero no se limita a, todas las pautas de seguridad requeridas mientras se encuentra en la instalación.

Visitantes		Los visitantes siempre deben estar acompañados por su anfitrión. La credencial de visitante debe usarse en todo momento en la instalación.
COVID-19		Se deben usar cubiertas faciales en todo momento en la instalación. Las prácticas de distanciamiento social deben cumplirse en la mayor medida posible mientras se encuentre en la instalación.
Límite de velocidad del tráfico		Los visitantes deben cumplir con los límites de velocidad del tráfico designados en toda la instalación.
Actos inapropiados		Cualquiera de los actos inapropiados resultará en la remoción inmediata de la instalación.
PPE		PPE siempre debe usarse en todo momento en la instalación o en el patio de la instalación.
Drogas y alcohol		PCC prohíbe el uso o posesión de drogas y alcohol en las instalaciones.
Armas de fuego		PCC prohíbe el uso o posesión de armas peligrosas en la instalación.
Menores de 18 años		PCC prohíbe que cualquier persona menor de 18 años ingrese a las instalaciones del almacén o al patio. Los visitantes de la oficina deben estar alojados.
Mascotas		PCC prohíbe la entrada de mascotas a las instalaciones.
De fumar		Los visitantes deben fumar solo en las áreas designadas. Se debe contactar al anfitrión del visitante para cualquier pregunta.
Comida		Los visitantes deben comer solo en las áreas designadas. Se debe contactar al anfitrión del visitante para cualquier pregunta.

Moverse por la instalación		Se alienta a los visitantes a caminar solo en los pasillos peatonales marcados, utilizar pasamanos mientras estén en las escaleras y estar al tanto de los alrededores de las instalaciones.
Uso Electrónico		PCC prohíbe el uso personal de dispositivos electrónicos para tomar videos o fotografías que no sean productos propios del cliente. Está prohibido el uso de auriculares y audífonos.
Materiales peligrosos		Es posible que haya materiales peligrosos en la instalación. Los visitantes no deben tocar ningún recipiente o recipiente en la instalación. SDS están disponibles en la instalación. Las estaciones de lavado de ojos están ubicadas en toda la instalación.
Incidentes		En caso de un incidente (con lesiones o sin lesiones), el anfitrión del visitante debe ser notificado de inmediato. El anfitrión del visitante y el visitante deben completar un informe del incidente.
Primeros auxilios		En caso de que se requieran primeros auxilios, se encuentran disponibles equipos de primeros auxilios capacitados y botiquines de primeros auxilios. Se debe contactar al anfitrión del visitante para cualquier pregunta.
Evacuación de emergencia		En caso de que suene la alarma, detenga inmediatamente lo que esté haciendo y camine hasta la salida más cercana. No se detenga a recoger sus pertenencias. Todo el personal de la instalación debe reunirse en el área de reunión más cercana y esperar instrucciones. Si se encuentra en un lugar seguro, llame al 911. Los mapas de evacuación de la instalación están colocados en todas partes de la instalación como referencia.
